# Annual inflation down to -0.6% in the euro area


Down to -0.5% in the EU

**Euro area**<sup>1</sup> annual inflation was -0.6% in January 2015<sup>2</sup>, down from -0.2% in December. This was the lowest rate recorded since July 2009. In January 2014 the rate was 0.8%. **European Union**<sup>1</sup> annual inflation was -0.5% in January 2015, down from -0.1% in December. A year earlier the rate was 0.9%. These figures come from **Eurostat**, the statistical office of the European Union.

In January 2015, negative annual rates were observed in twenty-three Member States. The lowest annual rates were registered in **Greece** (-2.8%) and **Bulgaria** (-2.3%). Positive annual rates were recorded in **Malta** (0.8%), **Austria** and **Romania** (both 0.5%), **Sweden** (0.4%) and the **United Kingdom** (0.3%). Compared with December 2014, annual inflation fell in almost all Member States, except **Cyprus**, **Malta** and **Sweden**.

The largest upward impacts to **euro area** annual inflation came from restaurants & cafés and rents (+0.14 percentage points each) and tobacco (+0.07 pp), while fuels for transport (-0.77 pp), heating oil (-0.24 pp) and telecommunications (-0.05 pp) had the biggest downward impacts.

#### Annual inflation rates (%) in January 2015, in ascending order





- 1. The euro area and European Union data refer to the respective country compositions at a specific point in time. New Member States are integrated into the aggregates using a chain index formula.
- 2. The euro area flash estimate for January 2015, published on 30 January 2015, was -0.6%.
- 3. The *annual rate* measures the change of Harmonised Indices of Consumer Prices (HICP) between a month and the same month of the previous year, and the *monthly rate* compares the indices between the two latest months.
- 4. An *impact* is a measure showing the change in the inflation due to the inclusion of a sub-index. The impact takes account of both the weight and whether the inflation for that sub-index is higher or lower than the all-items inflation rate.
